#### The holder of this document has

- Knowledge of the anatomy, physiology, biomechanics, confirmation and stance of the limbs.
- Knowledge of legislative and regulatory requirements for the profession.
- Knowledge of the horse as a biological creature and its activities in the human/equine relationship.
- Knowledge of principles for physiological hoof care in both foals and adult horses.
- Knowledge of business finances and marketing.
- Knowledge of working methods when forging and welding basic and orthopedic shoes.
- Knowledge of commonly occurring equine diseases, hoof diseases and hoof injuries.
- Knowledge of orthopedic shoes and their therapeutic effects.
- Knowledge of current research and development within the profession.
- Skills in providing hoof care for different types of horses, and horses of all ages.
- Skills in producing, modifying and applying individually fitted, usable shoes for horses.
- Skills in working with horses, including sedated or pain influenced, in a manner that is safe and comfortable for both horse and human, taking animal welfare and infectious disease control in consideration.
- Skills in taking appropriate actions for the correction of limb deviations in foals.
- Competence to determine care requirements of the equine foot, taking all the equine's need in consideration, Assessing conformation, gait, structural correctness, and hoof shapes, and thereby adjusting the trimming and shoeing according to the individual horse and its requirement to perform.
- Competence to, independently or in consultation with a veterinarian, remedy various hoof diseases and orthopedic conditions. Taking appropriate actions and, for conditions that require so, producing or modifying and fitting suitable shoes.
- Competence to maintain an ethical approach to the animal, the customer and the profession.
- Competence to manage small business.
- Competence to assess and evaluate information and working methods to strengthen or dismiss a thesis. Set current research into practical action, and apply specialized knowledge in order to benefit development of the
- Competence to analyse their own work, recount this in both speech and writing. Identify the need for advice and assistance, and seek this from the relevant person.

#### **Further information**

The Higher Vocational Education Diploma requires a minimum of a Pass (Godkänt) in all courses. Five HVE credits correspond to one week of full-time studies.

A Higher Vocational Education Diploma is awarded if the study programme comprises a minimum of 200 Higher Vocational Education credits (HVE credits).

An Advanced Higher Vocational Education Diploma is awarded if the study programme comprises a minimum of 400 HVE credits, at least one quarter of programme time is spent on student placement, and the student has completed an independent project.

Entry requirement is successful completion of upper secondary education.
